#### 1.0 BID ADMISSION

#### 1.1 Definition

Throughout this document "Owner", "District", "The District", "District of Elkford" shall mean the **District of Elkford**.

#### 1.2 Submission of Bid

The Sealed Bid envelope shall be addressed to:

Submission of bids to the District via direct facsimile or email is not acceptable and all bids, and any revision to a bid, must be submitted in a sealed envelope, clearly marked with the bid number and project title. The Bid Form must be included with the Bid Package.

### 1.3 Closing Date and Time

Bids will be received up to 3:00 p.m., Mountain Time, October 4, 2022. Bids received after the closing time may be returned unopened.

### 1.4 Acceptability of Bids

Notwithstanding any other provision in the Bid Documents or any practice or custom in the industry, the District, in its sole discretion, shall have the unfettered right to:

- a) Accept a Bid which is not the highest Bid;
- b) Reject a Bid even if it is the only Bid received by the Owner;
- c) Accept any Bid;
- d) Reject any Bid;
- e) Reject all Bids;
- f) To waive any informality in the bids;

Bids that are unsigned, incomplete, illegible, unbalanced, and obscure or contain other irregularities may be rejected as informal.

If duplicate Bids are received, preference will be given to the Bid that was received first.

If a Bid contains a defect or fails in some way to comply with the requirements of the Bid form, which in the sole discretion of the District is not material, the District may waive the defect and accept the Bid.

Bids which contain qualifying conditions or otherwise fail to conform to the Instructions to Bidders may be disqualified, or rejected. The Owner may, however, in its sole discretion, reject or retain for its consideration Bids, which are non-conforming because they do not contain the content or form required by the Instructions to Bidders or for failure to comply with the process for submission set out in these Instructions to Bidders.

#### 1.5 Bid Pricing

Unless otherwise specified herein by the District of Elkford, all Bids are to be in Canadian funds. All purchases are subject to GST.

#### 1.6 Successful Bidders

Successful bidders will be required to issue FULL payment with cash or certified cheque within 7 days of being notified by the District. If payment is not received within the time frame, another successful bidder will be chosen. Item(s) must be removed from municipal property within 14 days after payment is made to the District.

If the successful bidder is not with a registered Fire Department, when purchasing emergency equipment, the emergency lights, sirens, and all other emergency equipment will be removed prior to the piece of equipment leaving the District's possession.

#### 1.7 Disclaimer

Bids for the surplus equipment are made on an "as is/where is" basis. The District of Elkford does not represent that the surplus equipment is suitable for any purpose, and does not provide any warranty as to the state of repair or mechanical fitness of the

surplus equipment. All sales are final. It is the buyer's responsibility to determine the condition and suitability of the equipment.

#### 1.8 Withdrawal

Bids may be withdrawn by written notice only, provided such notice is received by the Director of Engineering & Public Works prior to the time set for the opening of Bids. Upon closing time, all Bids become irrevocable. By submission of a Bid, the Bidder agrees that should they be successful, that Bidder will enter into a purchase contract with the District of Elkford.

#### 1.9 Amendments of Bids

A Bidder may amend or revoke a Bid by giving written notice, delivered by hand or mail to:

An Amendment or Revocation must be signed by the Bidder.

Any Amendment that expressly or by inference discloses the Bidder's Bid Price or other material element of the Bid such that, in the opinion of the District, the confidentiality of the Bid is breached, will invalidate the entire Bid.

#### 1.10 Bid Clarifications

The Owner in its sole discretion reserves the right to clarify any bid after closing and prior to award.

#### 1.12 <u>Freedom of Information</u>

The District of Elkford is subject to the provisions of the *Freedom of Information and an Protection of Privacy Act*. All Bidders are therefore advised that any Bid submitted in response to this Sale of Surplus Equipment will be treated as a public document and the contents therein may be disclosed upon written request if required to do so pursuant to the Act.


