# **Watering Restrictions in Effect**

With plenty of residents wanting to water their lawns and gardens, Elkford has bylaws in place to help preserve and protect our water supply throughout the drier months.

To ensure capacity of Elkford's reservoirs in the event of a fire emergency (and adequate water for all throughout the summer) watering between **April 1 and September 30** is to take place on odd or even numbered days, *corresponding with your address*, and within the hours of **4 to 10 a.m.** and **8 to 11 p.m.** only.



## **Being a Bear-Friendly Community**

The BC Conservation Service reported 31 bears euthanized in 2021 in the Elk Valley, with <u>none of these deaths</u> being attributed to Elkford.

Can our community make it two years running with zero bears destroyed? We think so! This summer, the District of Elkford is asking all residents and businesses to again do your part and help protect our local wildlife.

Fed bears = dead bears, and following a few simple guidelines can help reduce wildlife attractants—and the risks of urban encounters—dramatically for the entire community.

Here's how you can do your part:

- Always dispose of trash properly and store it securely.
- Remove bird feeders during months when bears are awake (birds can find plenty of food on their own during these seasons—feeders will do more harm than good by attracting bears, as well as unwanted pests like rats and mice to your yard).
- Compost responsibly and harvest all fallen fruit/berries from your trees.
- Lock up your garbage bin inside a basement, garage, shed or other secured outbuilding. You can also build/buy bear-resistant enclosures!
- Store food (and food waste) securely while camping.
- Need a bear-resistant garbage bin? The Public Works Department receives a supply of new bear-resistant bins each year. Call them at **250.865.4025** and ask to have your bin swapped out for one with clips for free (while supplies last)
- Place your garbage curbside **ONLY** between <u>5 and 7 a.m.</u> on the morning of garbage pickup (and be sure to unclip it at that time).

### **Ride Responsibly: ATV/ORV Reminders**

Our trail systems can't be beat—and we know it! Please help us keep our trails safe and enjoyable for everyone by riding responsibly. We have some of the most beautiful off-roading trails in British Columbia and enjoying this privilege comes with some important responsibilities.

In *previous* years, the RCMP had issued permits allowing ATV/ORVs to ride down the street to access the nearest trailhead from their residence. **Be advised that the RCMP has indicated that they are NO LONGER issuing permits in Elkford that would allow ATV/ORV users to ride on/down residential streets and highways. Riders who do not abide by the regulations governing off-road vehicles risk facing penalties and fines from the District of Elkford, the Province of British Columbia and the RCMP. Fines will also be incurred if you do not wear your helmet, carry your insurance and annual licence or properly display your plate.** 

The only condition in which an ATV/ORV rider can legally traverse a road is to dismount and cross the road directly to the trailhead on the other side (e.g., if the trail you are riding is intersected by a road, you may cross it to get to the other side; additionally, you may also cross at a controlled intersection, such as a stop sign or at traffic lights). Within the boundaries of the District of Elkford, you must carry a minimum of one million dollars in third-party liability insurance, carry a valid driver's licence, wear a helmet and take care to ensure that the crossing is safe.

### **Open Burning Ban in Effect August 4**

In alignment with the campfire ban across the Southeast Fire Centre's jurisdiction, we would like to remind all community members and visitors to adhere to the open-burning ban in effect, which includes a prohibition on campfires, backyard fires, fireworks, sky lanterns, burn barrels, binary exploding targets, air curtains, chimineas, tiki torches and more. This ban is in effect on both public and private land and is in place to help prevent human-caused wildfires and protect public safety.

## To report illegal burning or unattended campfires within the District of Elkford:

• Call Elkford Fire Rescue & Emergency Services at **250.865.4020** or call **911**.

## To report illegal burning or unattended campfires outside the District of Elkford:

• Call **1.800.663.5555** toll-free (or **dial \*5555** on a cell phone). You may also call this number to report wildfires, smoke columns and violations of wildfire regulations in British Columbia.

Please don't assume that others have reported a wildfire if you see one. Either dial \*5555 or call 911 *IMMEDIATELY* to report a wildfire. Your call could save lives!

Additionally, Elkford Fire Rescue has received several inquiries regarding outdoor stoves. The only outdoor stoves that may be used during a campfire prohibition are those that use liquid fuel, gaseous fuel or briquettes \*AND\* that are CSA-approved or ULC-approved. Note that as conditions change, the use of any outdoor stove apparatus may be further restricted.



# Warmer Weather = Wildfire Season!

In 2019, the District of Elkford was proud to be recognized with the FireSmart Canada Community Protection Achievement Award for our Community Wildfire Protection Plan and our investment in urban wildland interface fuel treatment, reduction and mitigation. But continuing to keep our community safe requires us all to do our part!

Please stay informed about current burning regulations, practise diligent fire safety, obey backcountry closures and off-road restrictions and be aware of the impact of your outdoor activities as we head into the warmer months. It's important to understand that wildfire spreads quickly from tree-to-tree and can produce sparks and embers that may travel distances of *up to two kilometres*. These embers may land on trees or homes well-ahead of the fire, making wildfires extremely dangerous.
